Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalised have meanings defined under the following conditions.

The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of these Terms and Conditions:

Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.

Account means a unique account created for You to access our Service or parts of our Service.

Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Ship2me.network, 60, Benoi Road, #02-15, Singapore, 629906

Content refers to content such as text, images, or other information that can be posted, uploaded, linked to or otherwise made available by You, regardless of the form of that content.

Country refers to: Singapore

Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.

Feedback means feedback, innovations or suggestions sent by You regarding the attributes, performance or features of our Service.

Service refers to the Website.

Terms and Conditions (also referred as "Terms") mean these Terms and Conditions that form the entire agreement between You and the Company regarding the use of the Service.

Use of the services

Good Conduct

1. Ship2Me Network is a non-exclusive Network of Freight Forwarders and International Logistics companies
2. “Ship2Me Network Members” must be local or regional Logistics companies with good reputations (regarding finance, operations, communications, sales coordination and other professional factors) which can be backed up with at least 2 third-party agency references from countries outside of the residence of their main head office.

3. "Ship2Me Network members" are attending the worldwide annual meeting on a regular basis, not missing two consecutive years without valid reason
4. "Ship2Me Network members" agree to send all their shipments pre-alert from the PRE-ALERT system of Ship2me Digital Platform

Awards/Fees agreement

5. Quotes are free to use inside the platform, however Ship2me reserves the right to block a member if the member is only using the quote to compare the rates and never works inside the group
6. For each shared shipment (Freehand, routed cargo, cross trade), "Ship2Me Network Member" will receive a bonus equivalent to \$5/shipment that will be deducted on the Renewable Membership
 1. Bonus can only be deducted from renewable Membership (limit equivalent to the annual Membership)
 2. Member cannot claim the bonus if leaving the group
 3. The bonus is not valid for shipment between the same company (group)
 4. The shipment details (MAWB & HAWB or MB/L & HB/L) must be received as a Pre-Alert inside the platform within 30 days from the transport day
7. "Ship2Me Network Members" accepts to pay their overseas agents within 30 days net
8. The Ship2Me Network logo should be placed in a prominent position on the member's own website (to be understood as part of Ship2Me Network), e-mail, whenever possible
9. Every shipment must be announced by the PRE-ALERT of Ship2me Digital Platform (mandatory)
10. Every shipment shared between Ship2me Members is eligible to the PPP Program

Copyright Policy

Intellectual Property Infringement
