ORDER

for
PERMANENT
INJUNCTION

The Plaintiff, the People of the State of California (People), acting by and through Rockard J. Delgadillo, as the City Attorney of Los Angeles, sought injunctive relief against defendants, including defendant "18th Street gang" an unincorporated association, and 18 named individual defendants;

WHEREAS all defendants have been properly served with the Summons and Complaint in this action;

WHEREAS Defendants RICHARD JIMINEZ (aka Mosco), TROY SHAW (aka Bandit/Termite/J-Fly), and LUIS VERGARA (aka Skinnee/Skins/Lil Boy) are dismissed

1 without prejudice from this action, each now deceased;

2 **WHEREAS** Defendant EFRAIN MORENO (aka Woody) stipulated to Permanent
3 Judgment on Feb 6, 2004;

4 **WHEREAS** Defendants JORGE INZUZNA (aka Clown) and CARLOS
5 VILLALOBOS (aka Shorty), after a hearing on the merits, were determined to be as
6 alleged:

7 **WHEREAS** all remaining defendants having defaulted, including Defendants:
8 ALEXANDER ALVARADO (aka Smoke/Smokey/Smokie/Smokster), ERIC CAMERENA
9 (aka Smiley/Toro), NEFTALY GONZALES (aka Gizmoe/Chucky), GUSTAVO GUZMAN
10 (aka Bullet/Pelon), EDGAR LOPEZ (aka Smiley/Pelon), MARIO MARTINEZ (aka
11 Funny/Spooky), ELMER (OMAR) QUEVEDO (aka Solo/Husky), OSCAR RAMIREZ
12 (aka Mousie), JESUS RAMOS (aka Lil Man), BENJAMIN SILVA (aka
13 Sonny/Flaco/Benn), CARLOS TOVAR (aka Trusty), ALBENO VELASQUEZ (aka Beno),
14 and the 18th Street Gang, an unincorporated association,

15 **WHEREAS** all remaining DOE Defendants have been dismissed;

16 **WHEREAS** after considering the memorandum of points and authorities,
17 declarations, attached exhibits, Requests for Judicial Notice of Criminal Convictions,
18 and all pleadings, papers, files and records on file herein, this Court finds by clear and
19 convincing evidence that: 1) defendant gang, 18th Street, is a criminal street gang as
20 defined in Penal Code section 186.22; 2) each of the named individual defendants is a
21 member of the 18th Street gang, a criminal street gang; 3) each and together, these
22 defendants have created and maintain a public nuisance in an area hereinafter
23 described as the Alsace Safety Zone (or Alsace Target Area); and 4) the Alsace Safety
24 Zone, consisting of one portion of a neighborhood, in the City of Los Angeles, bounded
25 by Westhaven Street to the North, Jefferson Boulevard to the South, Alsace Avenue to
26 the East, and Hauser Boulevard to the West, (map included on Page 5), is adequately
27 defined geographically, and narrowly tailored to protect the community from the public
28 nuisance created by defendants;

1 **GOOD CAUSE HAVING BEEN SHOWN, IT IS HEREBY ORDERED:**

2 1. Defendant gang **18th Street**, and all of its members, and all persons
3 acting under, in concert with or for any of them, including but not limited to, defendants
4 ALEXANDER ALVARADO (aka Smoke/Smokey/Smokie/Smokster), ERIC CAMERENA
5 (aka Smiley/Toro), NEFTALY GONZALES (aka Gizmoe/Chucky), GUSTAVO GUZMAN
6 (aka Bullet/Pelon), JORGE INZUNZA (aka Clown), EDGAR LOPEZ (aka Smiley/Pelon),
7 MARIO MARTINEZ (aka Funny/Spooky), EFRAIN MORENO (aka Woody), ELMER
8 (OMAR) QUEVEDO (aka Solo/Husky), OSCAR RAMIREZ (aka Mousie), JESUS
9 RAMOS (aka Lil Man), BENJAMIN SILVA (aka Sonny/Flaco/Benn), CARLOS TOVAR
10 (aka Trusty), ALBENO VELASQUEZ (aka Beno), and CARLOS VILLALOBOS (aka
11 Shorty),

12 **ARE HEREBY** enjoined and restrained from engaging in or performing, any of
13 the following activities in the Alsace Safety Zone (or Target Area) extending from
14 Westhaven Street to the North, Jefferson Boulevard to the South, Alsace Avenue to the
15 East, and Hauser Boulevard to the West, and extending 100 yards to the outside of
16 each of these four boundaries:

17 (a) **Do Not Associate.** Standing, sitting, walking, driving, gathering, or
18 appearing anywhere in public or in public view, as defined in Health and Safety Code
19 section 11530(b) with any two or more known 18th Street gang members including but
20 not limited to defendants named herein. This prohibition shall not apply when all
21 individuals are within a dwelling unit as defined in Los Angeles Municipal Code (LAMC)
22 section 12.03;

23 (b) **No Guns or ILLEGAL Weapons.** While appearing anywhere in public or
24 in public view, as defined in Health and Safety Code section 11530(b): 1) Possessing
25 any firearm, ammunition or illegal weapon as described in Penal Code section 12020,
26 whether or not concealed, or 2) knowingly remaining in the presence of anyone who is
27 in possession of such firearm, ammunition or illegal weapon; 3) knowingly remaining in
28 the presence of such firearm, ammunition or illegal weapon

1 (c) **No Obstructing Traffic.** Blocking the free passage of any person or
2 vehicle on any street, walkway, sidewalk, driveway, alleyway, or other area of public
3 passage;

4 (d) **Obey Curfew.** Violating municipal code ordinances regulating curfews;

5 (e) **No Graffiti or Vandalism Tools.** Damaging, defacing or applying graffiti
6 to any public or private property not his own, including any building, fence, wall, garage
7 door, street sign, street, tree, pole, utility or telephone box, or vehicle; possessing any
8 aerosol paint container or graffiti tool in a public place, or any other marking substance
9 as defined in Penal Code section 594 *et seq.* with the intent to commit vandalism or
10 graffiti;

11 (f) **Stay Away From Drugs.** Selling, attempting to sell, possessing or using
12 without a prescription, any controlled substance or related paraphernalia, including
13 rolling papers and pipes used for illegal drug use, as defined in Health & Safety Code
14 section 11364 *et seq.*

15 (g) **No Intimidation.** Harassing, intimidating, or threatening the peace of
16 safety of any person, whether in retribution for any past complaint or to prevent a future
17 complaint about Defendants' gang activities, including complaints to law enforcement
18 officers, or for any other unlawful purpose;

19 (h) **No Lookouts.** Acting as a lookout, whistling, or otherwise signaling with
20 a flashlight, walkie-talkie or other means to warn another person of an approaching law
21 enforcement officer, or soliciting, encouraging or employing another to do so;

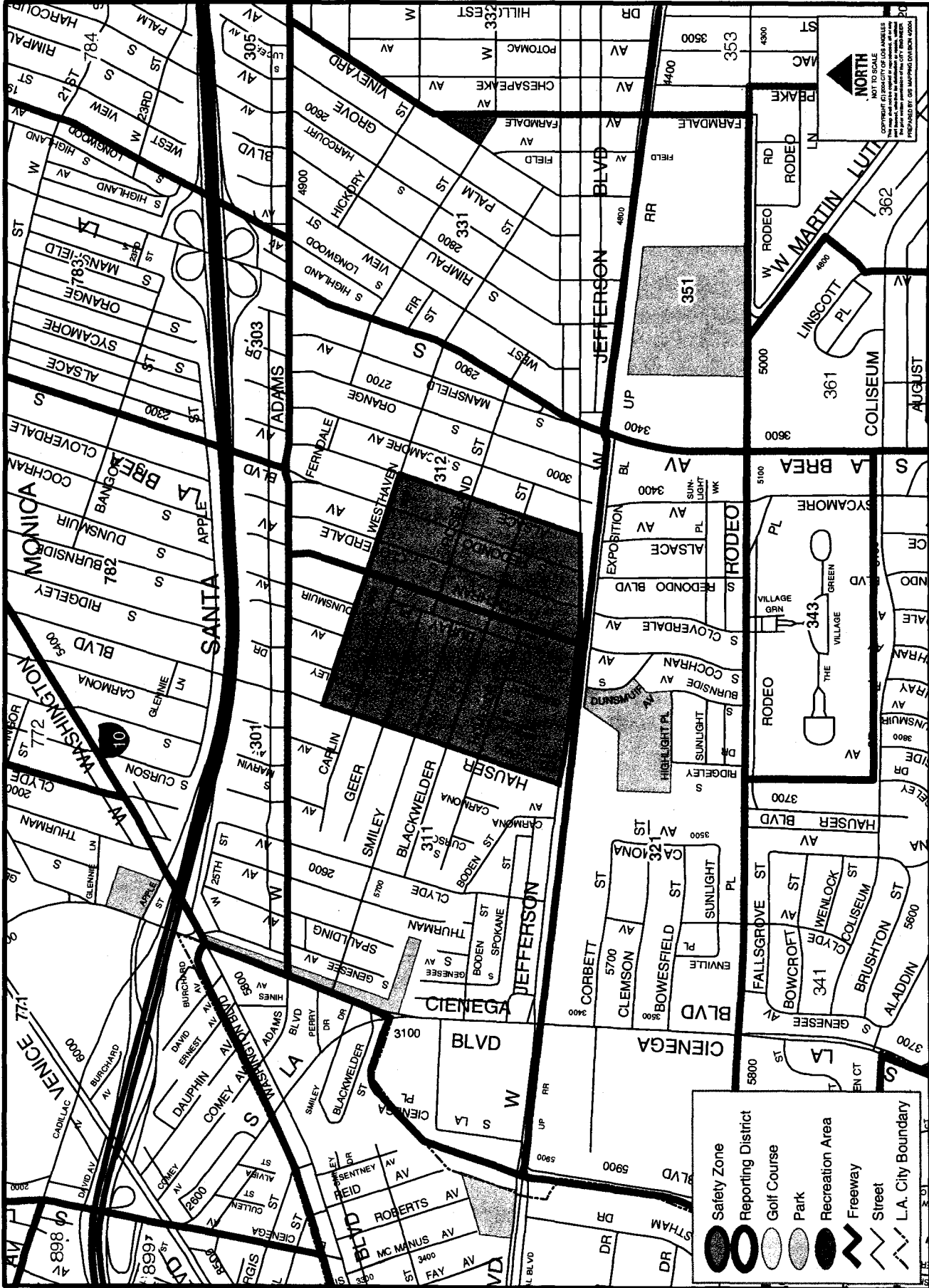

3 congregating or associating in the common areas or in public view within or around the
4 property located at 2903 South Cloverdale Avenue, City of Los Angeles, but not
5 including when all individuals are within a dwelling unit as defined in Los Angeles
6 Municipal Code section 12.03.

7 3. Each party shall bear its own costs and attorney fees in this action.
