1 After considering the declarations of officers and gang experts, Request for Judicial Notice, and
2 all pleadings, papers, files and records on file herein, this Court finds by clear and convincing evidence
3 that the conduct of 18th Street and its members constitutes a public nuisance in the Safety Zone; and
4 therefore, good cause appearing,

5 **IT IS HEREBY ORDERED THAT:**

6 1. Defendants Andy Alfaro (Dice), George Alfaro (Chato), Samuel Alfaro aka Samuel
7 Romero (Casper/Green Eyes), Alvaro Anaya aka Alvaro Bariantos (Moco), Hugo Arias (Lil Lazy),
8 Armenak Badoyan (Risky/Loks), Jose Becerra (Mouse), Edgar Castillo aka Osbaldo Hernandez (Ghetto
9 Boy/Lento/Perico), Ricardo Fuentes Cortez aka Ricardo Cortez Fuentes (Baby Oso), Daniel Guzman
10 (Bicho/Cryer/Hyper), Carlos Hernandez aka Juan Carlos Gomez aka Mauricio Martinez (Moreno),
11 Marcos Lopez aka Ernesto Conde aka Roberto Duran (Tury), William Maude (Frost), Oscar Montes
12 (Casper), Luis Moreno (Baby Inch/Woody), Rafael Nafarrate aka Joe Garcia (Chucky), Francisco
13 Pineda (Trek), Richard Ramirez (Moreno/Stalker), Richard Reyes (Spanky), Oscar Rico (Blackie),
14 Walter Roa (Oso/Bear), Daniel Tapia (Lil G/Lil Gangster), Carlos Torres (Trouble), Salvador Torres
15 (Lil Scrappy), Richard Zepeda (Gangster/Crow) and Juvenile #1, 18th Street, its members, and all
16 persons acting under, in concert with, at the direction of, in association with them or any of them, for the
17 benefit of the 18th Street, are restrained and enjoined from, engaging in or performing, directly or
18 indirectly, any of the following activities in the Safety Zone (attached as Exhibit 1), bounded by James
19 M. Wood Boulevard to the north, the 110 Freeway to the east, the 10 Freeway to the south, Hoover
20 Street to the west, and extending 100 yards to the outside of each of these four boundaries:

21 a. **Do Not Associate:** Standing, sitting, walking, driving, gathering or appearing
22 anywhere in public view, in a public place or in anyplace accessible to the public, with any other named
23 individual defendant or with any other known 18th Street gang member, including but not limited to the
24 individuals depicted in the photographs attached as Exhibit 2. This prohibition shall not apply in either
25 of the following situations: (1) when all individuals are inside a school attending class or on school
26 business or (2) when all are inside a church or religious institution for purposes of worship; provided,
27 however, that this prohibition against associating shall apply to all methods of travel to and from any of
28 those locations;

1 b. **No Intimidation:** Confronting, intimidating, annoying, harassing, threatening,
2 challenging, provoking, assaulting or battering any person who lives, works, visits or passes through the
3 Safety Zone or any person known to be a witness to, or victim of, any 18th Street activity or any person
4 known to have complained about any 18th Street activity;

5 c. **No Guns or Illegal Weapons:** (1) Possessing any gun, ammunition or illegal
6 weapon as described in Penal Code section 12020, whether or not concealed, while in public view, in a
7 public place or in anyplace accessible to the public, (2) knowingly remaining in the presence of anyone
8 who is in possession of such gun, ammunition or illegal weapon while in public view, in a public place
9 or in anyplace accessible to the public, or (3) knowingly remaining in the presence of such gun,
10 ammunition or illegal weapon while in public view, in a public place or in anyplace accessible to the
11 public;

12 d. **Stay Away From Drugs:** (1) Selling, possessing or using, without a prescription,
13 any controlled substance or marijuana, or related paraphernalia, including, but not limited to, rolling
14 papers and pipes used for illegal drug use, (2) knowingly remaining in the presence of anyone selling,
15 possessing or using, without a prescription, any controlled substance or marijuana, or such related
16 paraphernalia, or (3) knowingly remaining in the presence of any controlled substance or marijuana, or
17 such related paraphernalia;

18 e. **No Lookouts:** Acting as a lookout by whistling, yelling, or otherwise signaling,
19 by any means, to warn another person engaged in unlawful or nuisance activity of the approach of law
20 enforcement officers, or soliciting, encouraging, coercing or employing another person to act as such
21 lookout;

22 f. **No Hooks:** Acting as a hook by approaching, signaling or otherwise attracting
23 another individual for the purpose of drug sales, or soliciting, encouraging, coercing or employing
24 another person to act as such hook;

25 g. **No Obstructing Traffic:** Obstructing, impeding or blocking the free passage of
26 any person or vehicle on any street, walkway, sidewalk, driveway, alley, parking lot or other area of
27 public access;

28 h. **No Approaching Vehicles:** Approaching or signaling any occupied motor

1 vehicle on any street, public passageway or parking lot for the purpose of drug sales;

2 i. **Stay Away From Alcohol:** Drinking or possessing an open container of an
3 alcoholic beverage in public view, in a public place or in anyplace accessible to the public;

4 j. **No Graffiti or Vandalism Tools:** Damaging, defacing, marking, painting or
5 otherwise applying graffiti on any public or private property, or possessing any aerosol paint container,
6 felt tip marker or other marking substances that can be used to paint, spray paint, etch, mark, draw or
7 otherwise apply graffiti;

8 k. **No Loitering:** Loitering in public view, in a public place or in anyplace
9 accessible to the public for the purpose of engaging in graffiti, drug-related activity or any other illegal
10 purpose and

11 l. **No Trespassing:** Being present on or in any property not open to the general
12 public, except (1) with the prior written consent of the owner, owner's agent or person in lawful
13 possession of the property or (2) in the presence of and with the voluntary consent of the owner, owner's
14 agent or person in lawful possession of the property.

15 2. The People shall not be required to post an undertaking pursuant to Code of Civil
16 Procedure section 529, subdivision (b)(3).

17 3. This order shall supersede the Judgment Granting Permanent Injunction After Default
18 issued on August 9, 2002.
