

# LOS ANGELES CITY ATTORNEY'S OFFICE

## PETITION FOR REMOVAL FROM THE CENTRAL CITY INJUNCTION

**This form is for use by persons in the City of Los Angeles who have been served with the Central City Injunction and who want the opportunity to demonstrate that they should not be restrained by this Injunction because they no longer are, or they never were, involved in the sale of narcotics or a member of the Grape Street Gang. A Spanish language version of this form is also available.**

### **ELIGIBILITY:**

The Los Angeles City Attorney's Office has put in place a review process for those persons in the City of Los Angeles who believe they were wrongly served with the Central City Injunction for the following reasons:

1. The served person was not involved in the sale of narcotics; or
2. The served person is not a member of the Grape Street gang; or
3. The served person was properly served but has since ended his/her involvement in the sale of narcotics or association with the Grape Street gang.

The review process is intended to be informal and does not require the filing of any papers with a court or any appearances before a judge. It does, however, require that you either submit a completed version of this form to the City Attorney's Office or otherwise provide us with the information requested by this form.

The Central City Injunction will be enforced against you only if you have been personally served with it. To be eligible for removal from the Central City Injunction if you have been personally served, you must provide sufficient information for the City Attorney's Office to positively confirm that:

- 1) You no longer are, or you never were, involved in the sale of narcotics; **and/or**
- 2) You no longer are, or you never were a member of the Grape Street gang; **and/or**
- 3) You are not now acting, and you will not in the future act, to promote, further, or assist any of the activities prohibited by the Central City Injunction; **and**
- 4) You are not a member of any other criminal street gang.

**THE REVIEW PROCESS:**

The review process is conducted by a senior attorney within the City Attorney’s Office who is not involved in the enforcement of injunctions. The attorney will review all of the information in your Petition, as well as any other available and reliable information concerning your past and present involvement in the sale of narcotics and/or membership in or involvement with the Grape Street Gang. The attorney may contact you for additional information and may contact other people you know who may have information relevant to the review process. You will be advised of the decision to remove or not to remove you from the Central City Injunction at your home address, or, if you prefer for safety or convenience reasons, at another address. If your Petition is denied (and you are not removed from the Central City Injunction at this time), you may submit a new Petition when you have significant new information to support your claim.

**CONFIDENTIALITY:**

The City Attorney’s Office will keep the information you provide in this form confidential to the extent permitted by law.

The City Attorney’s Office will not use the information provided in this form to prove any fact essential to proving any criminal charge the City Attorney’s Office may bring against you in the future. (However, such information may still be used to cross-examine you should you testify at a trial in a case brought by the City Attorney’s Office and should your testimony be inconsistent with the factual information provided in this form.)
