

New Skating Rink Is

Now Under Construction

Many residents who became roller-skating enthusiasts before the South Davis roller rink burned a few years ago, will be happy to learn that construction for a new skating rink has begun.

EVERETT W. Reed, Kaysville, manager for Magec, Inc. said the building will be 160 by 70 feet. And, its location will be ideal for the Bountiful area. It is being built at 6602 S. 350 W. This is on alternate 91 just south of 6500 S. It is to be on the east side of the street, just north of the Redwood Nursery.

Architect for the building was Willard Nelson and Ashton E. Williams is the builder. A building permit for \$25,000 for the project was issued by the county planner's office for a cinder block construction building.
