Good Day everyone,

I, confirm/attach receipt of a communication from a man John R. Hatch September 21st, 2021;

September 13th & 17th 2021 Notice: Trespass was sent and received by all accept to OPPA agents;

Today and on the public record Rob, Terry and Randy at OPPA have received Notice filed and evidence;

All communications and evidence is found at bit.ly/awcevidence to insure truth & transparency to public;

As of September 22, 2021 not a single piece of evidence produced to Notice filed has been received;

Christopher James is my counsel on this trespass occurring against i and the people worldwide;

We have honorably laid bare a colossal lie all of us have been fed with verifiable evidence;

If you require more time to review and vet we understand...but to ignore claims filed is not an option;

The communication from John is nothing shy of an attempt to obstruct justice to genocide occurring;

Does everyone not understand what you are doing to your fellow man? Our Oaths are compromised;

The very foundations of trust the people have placed in us is being destroyed under your control;

A female OPP officer for 20 years wrote Rob Stinson proving the forced injections [trespass] are poison;
