

WARRANT OF ARREST

TO: The Marshall

You are required to arrest the ship "HARBOUR MASTER" at the port of Saint George in the island of Grenada and the cargo now or lately laden in her together with the freight due for the transportation of it and to keep the same under safe arrest until you receive further orders from the Court.

The Claimants claim:



- i. A warrant be issued for the arrest of the vessel "HARBOUR MASTER" which forms the subject matter of this action;
- ii. General Damages for personal injuries, in consequence of the wrongful act, to wit, assault and battery, neglect or fault of the master and crew and any other person of whose wrongful act, neglect or default the person in control of the ship is responsible inter alia.
- iii. General Damages for injury to feelings, mental suffering, distress, humiliation, anger and indignation as a result of the wrongful act of assault and battery;
- iv. Aggravated and/or Exemplary Damages
- v. Special Damages in the sum of \$140.00 to date and to be assessed further;
- vi. Interest pursuant to section 27 of the West Indies Associated States Supreme Court Act, Cap 336 of the 2010 Continuous Revised Edition of the Laws of Grenada;

vii. Costs; and

viii. Such further or other order or relief as this Honourable court deems fit.


