## KMAN music linked to violent act at Boca Secondary School



KMAN - will not be allowed to perform

The violence culture around controversial Trinidad artiste KMAN has apparently reached into the school system in Grenada

THE NEW TODAY was told about a violent incident which took place Wednesday at the Boca Secondary School in which a school boy pulled out a knife against another over the playing of KMAN's music

The Royal Grenada Police Force (RGPF) has confirmed the incident at the school which is located in the St George North-east constituency of former Minister of State for Sports ad Culture Ron Redhead.

According to a well-placed source, the principal of the school Marsha Lendore called the Central Police station on the Carenage to file a report about a 16-ye ar old student who attacked another one with "a knife and toy gun."

A police party rushed to

the school and took the school boy into custody.

He was charged for the

offence of being in possession of an offensive

weapon and granted bail. The source told **THE NEW TODAY**: "The boy who was threatened was playing Kman's "bad tunes" and knife boy did not like it. This is of great concern since it means that knife boy sides with gang opposed to Kman. It also means that the boy's life is in danger after he reported knife boy.

Several unsuccessful attempts were made to contact the school principal for comment on the There are also reports circulating that some students are now spotted wearing red or blue scarfs which seem to suggest that they might be linked to a particular

Gang in the country.
The KMAN-linked incident at Boca Secondary School comes as the Mitchell-led Dickon National Democratic Congress (NDC) government has taken a decision to prevent the artiste from the twin island republic making an appearance at the appearance at the February 6 show at the CowPen in La Filette, St Andrew.

A top party member said that the Cabinet of Ministers met on Tuesday and KMAN was the subject of discussions in light of reports that a contract is out to assassinate him a rival Gang in

According to source, one of the action that is being contemplated is to deny the request by the promoters of the show for a work Permit to be granted for KMAN to perform

on the island.
"This performance will not take place," said a well-placed official within the Ministry of National

Security.

There has been an uproar on the island following reports that the artiste who is believed to have a price tag on his head for possible execution in ongoing gang war-fare in the twin island republic is being brought to Grenada by a promotional outfit known as "Rollout Promotions, The CowPen Big Yard &

Bogozo Barbershop." KMAN is known to have performed at CowPen

just over a year ago.

The February 6 show that is already being promoted on go2fete.com is due to take place one day before the island celebrates its Golden Jubilee Independence.

Grenadians are said to be fearful that a performance by KMAN can attract violence by those after him which could put a severe damper on the Independence celebrations in the Spice Island.

Several prominent locals have contacted THE out that they have voiced their strongest opposition to the entry of the controversial figure at "the highest level" within the Royal Grenada Police Force

"If this artiste is really coming here then security needs to be tripled because he actually has a bounty on his head, said one Grenadian.
This is an obvious refer-

ence to the two attempts to assassinate the artiste within the past five months in Trinidad with the latest being two days after Christmas Day.

death but three of his associates were killed in a hail of bullets along with an innocent bystander in an area close to the Churchill Roosevelt Highway between Curepe and St Augustine.

KMAN also survived a previous assassination attempt on his life in October when armed gunmen attacked and left him and another man injured in the incident.

One concerned Grenadian asked the question: "How and who is the promoter that even

thought about bringing

this gangster here?"

A Grenadian in the Diaspora warned the authorities in his homeland to do everything possible to keep out persons or gangs that can come in and influence the

youths in Grenada. He said: "That group (Trinidad Gangsters) will be a bad influence for the youths here. It is the right thing to ban them. That will give the groups like the Mt. Horne possee encouragement. People who are aware of the situations will think otherwise. The "empty youths" are easily misled. Therefore, it is crucial to keep out negative influences, which can trigger more negative activities within our societies.'

former Grenada Parliamentarian suggested that the Treaty of Chaquaramas that led to

the formation of the Caribbean Community (CARICOM) should be relooked to curb the right to freedom of travel by everyone within the English-speaking Caribbean.

He said that persons who are linked to gang violence, and promote violence in their music should not be allowed to travel freely within member states of Caricom.

...This glorification of gun violence is a sick counterculture being transplanted from Trinidad. It started first in Jamaica and South Africa. The government should move swiftly to ban this artiste (KMAN) and put in place a policy that would seriously curtail those artistes who thrive within this subculture coming Grenada," he added.

It shows that both parties are prepared to put dollars in front of the safety and well-being of the people of Grenada.

The 19-month old Dickon Mitchell-led Congress administration must do everything possible to ensure that KMAN is kept out for now and to avoid the possible spreading of bloodshed on the eve

of our 50th anniversary of independence.

History will never forgive the members of the Cabinet of Grenada for not acting in such a manner that our showpiece event will never be remembered as one with blood-letting.

This gem of an island has seen enough innocent blood being shed, especially the carnage that took place on October 19, 1983 on Fort George/Rupert when Prime Minister Maurice Bishop was executed by a rival faction within the then ruling New Jewel Movement (NJM) that created the Grenada Revolution.

The professional killers in Trinidad have shown no mercy to innocent



## **Police charge Bobby Steele for Causing Harm**

incident in the south of the island at an entertainment place known as "Rumors" and operated by a major political activist of the New National Party (NNP), police have finally laid a charge on the businessman.

Robert "Bobby" Ashley Steele was charged Sunday by the Royal Grenada Police Force (RGPF) for the offence of Causing Harm to senior public officer Mervyn Haynes, on instructions from the Director of Public Prosecutions (DPP) Christopher Nelson.

Hours later, Steele was released on bail and will have to appear at the George's Magistrate's Court on February 16 for the first hearing of the case.

Haynes was allegedly beaten by Steele after he visited "Rumors" in November to ask him to low down the music as the noise was disturbing medical students of St George's University (SGU) who were living in his apartment build-ing in the True Blue

After the incident, the business operator went to South St George Police station to file a complaint against Havnes.

THE NEW TODAY understands that when the senior public officer arrived at the station to make a report about the incident, he was taken into custody, placed in a cell while Steel was allowed to leave the station

When guizzed about the issue, a senior cop indicated that the investigation carried out subsequently suggested that Steele was the alleged aggressor in the incident.

'I found out that Steele went ahead to report (to the station). But it was discovered after that he was the aggressive one to Haynes whom he beat up. It was also ver-ified that there was no intent by Haynes to use his firearm against Steele," he said.

Haynes is known to be the holder of a licensed firearm but was said to be only attempting to strike Steele with the weapon in order to keep him at a distance.

In commenting on the incident two months ago, Haynes said: "I became fearful for my life, and I pulled my licensed firearm, which was not engaged (locked), and attempted to hit him with it as I received more punches from him.

Two of the security guards at the establish-

ment quickly broke up the tussle. I received a busted lip, swelling on my face and forehead and trauma to my eyes to which I visited the hospital (was) exam-ined and given a medical report.

"I subsequently made a complaint on Bobby. I was held overnight in the cell at South St. George's and released pending further investigation. Bobby came in and gave his report on Sunday when he made comments at the station that he had given me 3 good punches, and I assaulted him. My eyes got damaged in the tus-

"Despite (of me) making a complaint against him, he left the station after just around two hours being there. This problem of extremely

loud noise has been going on for around 8 years now and despite many complaints to the South St. George Police Station, there has been no action other than a few times when they came and asked them to turn down the music, and after the police leave the music would go right back up.
"I spent the night in

the cell and wasn't released until around 4.00 p.m, Sunday afternoon when Bobby Steele was allowed to come in and give his statement and leave after 2 hrs on Sunday.

Haynes has also given instruction to his attorney, Ruggles Ferguson, KC to take civil legal action against Steele for the assault on him. Justice Agnes Actie has ruled in favour of one of the island's top architects who brought a case against a Grenada diplomat.

The case involved Erik Johnson Atlantic Partnership Architects Inc and Ambassador Richard Nixon, a major player in Grenada's controversial passport selling scheme known as Citizenship By Investment (CBI).

Issues

[13] The defendant on the other hand avers that the oral arrangement between the parties was for the provision of conceptual drawinas for the purposes of submission to the Physical Planning Authority for planning permission, and that "Fee Appraisal 1" issued by the claimant covered all work that was done for the conceptual plans. The defendant asserts that there is no consideration moving from the defendant to the claimant with respect to "Fee Appraisal

[14] It was borne out in the trial that the claimant was to prepare architectural designs sufficient for a planning submission. The defendant admitted under cross examination that the first set of drawings by the claimant were rejected by him, and that they were never submitted for planning approval. It is also the evidence that the claimant thereafter continued work on a new set of designs.

[15] The claimant's evidence is that the process of producing the detailed plans took place over a period of time. It commenced with the defendant's approach to the said Erik Johnson on on one prospect of providing architectural services, to the preparation of initial Erik Johnson on the designs, to the drawing of a second design of a more intense development, to several changes/alterations being made on the instruction of the defendant, to the completion of all drawings and designs.

## Acting GBA President raises Cybersecurity concerns

"As we embrace the technological advancement of the court, particularly creating the paperless trail, we

have to be mindful of the lurking presence of cyber threats and cyberattacks, which can disrupt the computer information system, computer networks and infrastructure," Attorney Paul warned.

Paul warned.
Highlighting the risks associated with the ECSC's E-Litigation Portal (ELP), which facilitates integrated e-filing and case management applications, the attorney expressed concerns about the looming possibility of cyberattacks.

He said while there has not been any known attempt so far, the likelihood of cyberattacks is a real possibility.

real possibility.

Specifically, he mentioned the threat of ransomware, a type of malware that encrypts electronic data and files, making them inaccessible to the victim.

Hackers, in turn, are said to often demand ransom payments for the release of the compromised information.

Attorney Paul stressed the importance of cybersecurity measures to safeguard sensitive court data, cautioning legal professionals to be vigilant against potential disruptions to the computer information system and infrastructure.

"We, as attorneys and colleagues, must sensitise ourselves on cyberattacks and cyber security to protect our data, and the data of our clients since most of the information of our clients may be in cyberspace on the litigation portal," he said.

Attorney General and Minister for Legal Affairs, Senator Claudette Joseph in her remarks during last week Friday's ceremony, cited initiatives of the ruling National Democratic Congress (NDC) administration in St. George's to implement a paperless system in Parliament and Cabinet in keeping with the Court's digital drive in administering Justice.

"Moving the operations of

"Moving the operations of the court to a digital platform also synchronises well with the thrust in the other arms of the government to go paperless," she told the special court sitting.

"For instance, in Grenada, we operate a paperless Parliament and a paperless Cabinet. So, it is in order that the other arm of the state must go paperless as well," she said, while Attorney Joseph emphasised the commitment of the NDC regime to embrace digitisation in going forward.

## Fr. Marcin Rumik: You must be prepared to serve

ing filled the Blessed Sacrament Roman Catholic Church at Grand Anse last Friday as members of the Legal profession from throughout Organisation of the Caribbean Eastern States (OECS) gathered to commemorate the opening of Law Year 2024.

Welcoming the judicial officers of the Eastern Caribbean Supreme Court to the church service was the Chief Celebrant, the Polish-born priest Father Marcin Rumik who told the congregation of mainly members of the Bar Grenada Association (GBA) that the Eucharist Service is an opportunity to be with God.

"I am very happy that you are here; that you see the need to come and to place yourselves in the things of the mer-ciful Father...," he said. The clergyman consonnel for their decision to become lawyers and encouraged them to be more like Jesus in their profession.
"As a priest I will tell

you simply to be like Jesus. We came to realise that the Bible tells us that Jesus actually is a kind of lawyer."

## E litigation gets a boost

The E litigation platform took center stage last Friday at the Radisson Grenada Beach Resort as the OECS Chief Justice Dame Janice Pereira spoke on the various innovative strategies implemented by the court over her tenure.

"Since 2018, we have made tremendous strides in transforming the court's filing and case management systems through our E litigation portal which we call the ELP. We cannot deny the very tangible benefits that we have seen since implementing the ELP," said Dame Janice.

Highlighting Grenada's reduced backlog of civil cases after the implementation of E-Litigation platform, the female

Chief Justice suggested that this should be replicated among the other

states.
"Significantly we have experienced a reduction in delays caused by our former reliance on a paper based system, a marked increase in the clearance rate, the greater ease in accessing and managing case files across the length and breadth of all members states and territories allowing the court to enjoy greater ease and flexibility of operation," she said.

"I am informed that here in Grenada, the case backlog for civil matters have been significantly reduced. This is a feat that ought to be emulated by the other member

states and territories," she added.

In seeking to uphold the Eastern Caribbean Supreme Court mission's statement, the Chief Justice admitted that the technological innovations that are now embraced were driven by necessity and choice.

"The Eastern Caribbean Supreme Court has always been committed to exploring and adopting innovations that elevate effectiveness within the wider justice system. In pursuit of our transformation, the court has relied heavily on information and communication technologies and has incrementally increased its use of technological advancement to make more appropriate and

efficient use of all resources," she told lawyers.

Dame Janice also informed the Bar that the ELP system has been utilised in matters such as appeal cases, as well as the family court, and civil court.

She recalled that the ELP was first executed in October 2020 in the family service department of the magistracy in the twin island states of Antigua and Barbuda.

"The world around us is rapidly changing and we must continuously keep our eyes on the future of technology to keep pace with the shifts in what constitutes efficient justice administration. I dare say that one of the greatest advantages of adopt-

ing a digitized case management system was keenly felt during the crisis of the COVID-19 pandemic."

She expressed that calamities and disasters can spark innovative strategies.

"Having access to an electronic means of filing and managing cases was

truly instrumental in preventing a near certain, crippling of the court's services during a time when being in close physical proximity was a danger to us all. Crises also provides opportunities. What courts around the world witnessed and embraced could only be referred to as the court technology revolution.

"The increased integration of modern technological applications into our day to day processes has not only made us more efficient but is also adequately equipped for effective crisis management."

The Chief Justice informed attorneys that the ELP will allow cases to be easily searched, stored and retrieved.

"In July 2023, we completed the ELP links for family and civil matters in the magistracy across all member states and territories. This has allowed the E filing and management of the current family and related domestic case types. Even in cases commencing before implementing the ELP, these cases can now be digitally managed in a manner which enhances case flow, searchability and importantly storage and retrievability.

Dame Janice disclosed that certain improvements have begun regarding the platform. "Feedback enhancing

"Feedback enhancing the operations of the system has been taken on board as it relates to the ease of payment facilities for child maintenance payment and the like," she said.

The Chief Justice also informed the Bar that the launch of the criminal module of the ELP means that the organisation of cases will now be exclusively online.

"We have also made great progress toward realising the launch of the criminal module in both the high courts and the magistracy across the member states and territories. The implementation of the criminal module will take us to a full digitisation of case management services in all cases and at all levels at all courts."

"Different personnel within the legal profession such as Directors of Public Prosecutor and Attorney Generals will be able to share information regarding the cases on the new platform

the new platform.

"A novel feature of our electronic case management system which is being pursued is the adoption of a cross sectional approach by automating information sharing between the various stakeholders in the management of criminal cases."

The hope, according to the British Virgin Islands senior attorney, will be the platform being used by members of the police force and that it will reduce inaccuracies linked to paper-based methods, boosting efficients.

ciency.
"It is hoped that it will be expanded to the police and correctional facilities. It is expected that the sharing of information across and the introduction of an automatic automated data exchange system will reduce the inaccuracies and delays often caused by paper based methods in criminal case management.

("(It will also) facilitate ease of cross institutional processes and allow for the allocation of human resources to other important tasks for greater efficiency."

Dame Janice announced that member states will be expected to gain access to the platform in the next few months.

Additionally, she said registrars have been shown the complimentary management software and it has been well received.

"I am pleased to say the criminal module of the ELP is nearing completion for full implementation with testing for full functionality currently

"I am reliably informed and therefore proud to announce that the first installation of the criminal module is on schedule to go live during the first quarter of this year with a complete roll out across all member states and territories by the third windtent of this year."

"I should also inform you that the court has been actively engaged in sourcing and implementing electronic jury management software to complement this system. Registrars have been given a demonstration and their feedback has been positive."



Those were the words of outspoken Barrister-at-Law Anselm Clouden in an interview with reporters on Wednesday taking issue with what appears to be another damaging attack against the ruling National Democratic Congress government of Prime Minister Dickon Mitchell, by the Leader of the main opposition New National Party

The controversy stems from Dr. Mitchell's utterances Monday night about an alleged ISIS presence in Grenada during an appearance on the Grenada Broadcasting Network (GBN) weekly 'To The Point programme' calling on the government to clear the air on the presence of the terrorist

group on the island.
"I would not want to live in a country where an organi-

sation like ISIS has any influence whatsoever. If it's not true that needs to be dealt with urgently and if it's true then something needs to be done because ISIS is banned in almost every country in the Caribbean and around the world," said Dr. Mitchell, the longest serving Prime

Minister of the country. Clouden, a Canadian trained barrister, decried Dr. Mitchell's attempt to associate a peaceful country like Grenada with the nótorious jihadist group. This, he said, has caused "irreparable damage to the integrity of Grenada" and

that it is "unfortunate that

the former Prime Minister, and the leader of the King's Opposition to have made such malicious statements

Clouden charged that "the brutality to which ISIS had maneuvered in the Middle East and elsewhere is unimaginable, and to associate such a peaceful country such as Grenada, to insinuate that that organisation is registered in Grenada, I think is reprehensible."

"If indeed ISIS has come to Grenada at all and was registered here he (Dr. Mitchell ought to have known because he was Prime Minister up until a vear and eight months ago. So, why say those things?

Clouden called on the Attorney General Senator Claudette Joseph to intervene in the matter in order to determine whether some form of legal action can be taken against the

former Prime Minister.
He noted that Dr. Mitchell "has been making these malicious falsehoods against the government and our caring and visionhas been working indefati-gably to begin the new journey to carry Grenada in a different direction."


The seasoned barrister

said that "the politics of propaganda, allegations and these things, that's of the past and has no relevance in our new dispen-sation," and called on Dr. Mitchell to produce docu-mentation to prove his ISIS claims or retract his malicious statements.

"Not only must he retract his statement because the world has listened to this but he must also give a full and unqualified apology to the people of Grenada, Carriacou and Petite Martinique," he added.

"And, it is in that context I think the Attorney General must now respond, or else this thing would go unchecked," he told reporters.

[19] The court is fortified of the claimant's provision of service beyond that of the conceptual plans in the similarities indicated similarities indicated above, as well as in the evidence of the receipt issued to the defendant by Quingdao Fuhaiyang Construction Group Ltd. In both receipts issued to the defendant by Quingdao Fuhaiyang Construction Group Ltd, it is stated that the work done was a "civil design review". Further, there are multiple emails before the court for the period of March 2016 to September 2017 between claimant's Johnson and the defendant. These emails show the continued involvement of Erik Johnson in the claimant's project, right up to the finalising of plans for construction.

[20] In Smith v Hughes1 Blackburn J. noted that:

"If whatever a man's real intention may be, he so conducts himself that a reasonable man would believe that he is assenting to the terms proposed by the other party, and that other party upon that belief enters into the contract with him, the man thus conducting himself would be equally bound as if he had intended to agree to the party's terms...

[21] Moreover in RTS Flexible System Ltd v Molkerie Alois Muller GmbH & Co (UK Production2 Lord Clarke stated that:

"Whether there is a binding contract between the parties and, if so, upon what terms depends upon what they have agreed. It depends not upon their subjective state of mind, but upon a consideration of what was communicated between them by words or conduct, and whether that leads objectively to a conclusion that thev intended to create legal relations and had agreed upon all terms which they regarded, or the law requires essential for the formation of a legally binding relation."

[22] The court is of the view that the defendant by his conduct in paying the amount detailed in the "Fee Appraisal 1" accepted the terms with respect to the valuation of the building scheme and the percentage payable to the claimant for its services under the oral contract, which, depending on the stage, could amount to 4% of the estimated building cost. At Stage A, this per-centage was 10% of the 4% fee, and at planning permission, this percent-age was 50% of the 4%

[23] There is also nothing to support the defendant's



lawyers in the matter

position that the claimant had agreed a fixed fee of \$28,000.00 exclusive of value added tax for its services. This is especially so when "Fee Appraisal 1" is described as "design drawings, Stage A", and "Fee Appraisal 3" contem-plates "professional services in connection with a scheme design" and references planning permis-

[24] The headnote of Reveille Independent LLC v Anotech Internaitonal

(UK) Ltd3 connotes that:
"It was well accepted that acceptance could be by conduct of the offeree, and it could be of an offer which was only in draft terms (Brogden v Metropolitan Rly Co (1877) 2 App Cas 666)."

[25] Certainly at the point of issuance of "Fee Appraisal 1" the defendant was aware of the 4% fee of the claimant, and by his conduct in further engaging its services, knew that a greater percentage of the fee would have been due for the more involved services which would have been required for planning approval.

[26] There is no evidence of the defendant challenging the fees up to the point of the claimant submitting "Fee Appraisal 3", and the defendant's denial of fees through his Attorney's letter of 7th December 2018. Instead, it is the evidence that when demand was made of the defendant by Frik Johnson for payment of "Fee Appraisal 3", the defendant, between the period 25th March 2018 to 24th October 2018, made representations to meet with Erik Johnson on that

[27] The court therefore finds that the conduct of the parties and the payment of the Fee Appraisal No 1 invoice by the defendant indicatés a clear intention that the parties were to be bound by the terms. Accordingly, the court accepts that the claimant has proved its

claim and the fees due and owing to the claimant were in the amount of \$140,000.00, exclusive of value added tax.

Whether the Defendant converted and used the drawings prepared by the claimant in the construction of the building

[28] The claimant pleads that the defendant, without the knowledge or consent of the claimant, converted or caused to be converted to his own use and benefit, the said architectural designs, plans and drawings of the claimant for the construction of the said

[29] Conversion is a tort in which the person entitled to the possession of a chattel is permanently deprived of that posses-sion and the chattel is converted to the use of someone else4. In Rattansingh v The Attorney General of Trinidad and Tobago and Doopan, which was upheld by the Judicial Committee of the Privy Council, Warner JA, opined as follows:

"To constitute conversion, there must be a positive wrongful dealing with the goods in a manner inconsistent with the owner's rights and an intention in so doing to deny the owner's rights or to assert a right inconsistent with them. The gist of the action is inconsistency. There need not be any intention to challenge the true owner's rigȟts. A demand and refusal is sufficient evidence of conver-

[30] Moreover in Clerk & Lindsell on Torts it is stat-

'Anyone who, without authority, receives or takes possession of another's goods with the intention of asserting some right or dominion over them, or deals with them in a manner inconsistent with the right of the true owner is prima facie guilty of con-version; provided there is an intention on the part of the person so dealing with them to negative the right of the true owner or to assert a right inconsistent

[31] Counsel for the defendant argues that the claimant has failed to establish that it holds a property right in respect of a chattel. She argues that a chattel is something that has physical existence, in the sense that it can be touched and is not immovable, and that the architectural drawings which were generated electronically are still accessible and in the possession of the Claimant. Counsel for the defendant relies Halsbury's Laws of England and Clerk and Lindsell on Torts.

[32] In Halsbury's Laws of England10, the authors state the following:

"In order to sue in conversion, the claimant must establish that he holds a property right in respect of a chattel. Conversion therefore affords protection to property rights relating to chattels. A chattel is something which has a physical existence, in the sense that it can be touched, and is not immovable..."

[33] Choses in action are described in Halsbury's Laws of England11, the authors state the following: "The expression 'chose in action' or 'thing in action' in the literal sense means a thing recoverable by action, as contrasted with a chose in possession, which is a thing of which a person may have physical possession. The meaning of the expression 'chose in action' or 'thing in action' has expanded over time, is now used to describe all personal rights of property which can only be claimed or enforced by action, and not by taking physical possession"

[34] In footnote (2) to that paragraph, Halsbury's Laws goes on to state:

"[it is] impossible to give

an accurate and complete definition of what it means and may include at the present day. The various kinds of property included under the term have little in common beyond the characteristic fact of their not being subjects of actu-al physical possession."

[35] A chose in action is capable of being the subject matter of theft, but not, as indicated above, of conversion12. Halsbury's Laws goes on to identify certain classes of chose s in action, including debts, rights under a con-

tract, rights or causes of action, shares, intellectual property, equitable rights and leases.

[36] The claimant in sub-missions did not pursue the issue of conversion or establish that its electronic drawings are a chattel capable of conversion, in light of the argument made of defendant counsel. Accordingly, the claim for conversion not pursued by the claimant is dismissed.

Conclusion

[37] For these reasons, the claimant succeeds on its claim for the payment of monies due and owing for professional fees provided to the defendant.

[38] It is therefore ordered and declared as follows:

(1) Judgment is entered in favour of the claimant against the defendant.

(2) The defendant shall pay the claimant the sum of \$115,000.00 being the balance of \$147,200.00 less the payment of \$32,200.00 with interest at the rate of 3% per annum from the date of filing the claim until judgment and at the rate of 6% per annum from the date of judgment until payment in full.

(3) Prescribed costs to be

paid to the defendant by the claimant pursuant to CPR 65.5(2)(b) within thirty (30) days of the date of this order.

Recently, the dance hall artiste has been grabbing news headlines in T&T after a brazen shooting in December 2023

financing.
Taiwan took Grenada to court in New York and a settlement was reached for repayment of the funds.

According Wei, Ambassador China believes that since the resumption of diplomatic relations

between the two countries, the ties have been developing steadily and there is now practical co-operation in various sectors that have yielded "useful results"

The Ambassador pointed to co-operation in the fields of infrastructure, education, healthcare, agriculture and low-income houses among others.

He praised Grenada for its stand on the "One China" principle and the reunification efforts between China and its renegade province of Taiwan.

noted that the Congress administra-tion on Tuesday issued a statement reaffirming its commitment to upholding "this one-China principle" and that the NNP also did the same with a similar statement.

"We appreciate this very much," said the Chinese ambassador.



## Action on criminal gangs and guns is urgent



Ecuador, once celebrated for its tranquillity, now finds itself at the epicentre of a distressing surge in gang violence, its streets marred by the ominous shadow of armed groups fuelled by the trafficking of illicit drugs.

On January 7, President Daniel Noboa

On January 7, President Daniel Noboa deployed the nation's armed forces to clean up prisons from which gang leaders were directing their criminal activities. This desperate response came after days of unrest, during which two formi-

dable gang leaders escaped from jail, prison guards were held hostage, and explosive devices wreaked havoc in cities across the country.

These events starkly illustrate a broader crisis, one that extends its menacing grip across Latin America and the Caribbean.

Ecuador, nestled between the world's two largest cocaine producers, Colombia and Peru, faces the dire consequences of its geographic vulnerability.

However, Ecuador's plight is not a solitary narrative; it is a haunting prelude to a regionwide symphony of chaos.

The issue of gangs, guns, and violence cannot be confined within borders. Governments are now awakening to the problem, but it has already spiralled out of control in some nations, while others are teetering on the brink.

The Caribbean, in particular, stands as a sobering example, with four of the five most murderous countries and territories in the region in 2022 being the Turks and Caicos Islands, Jamaica, Venezuela, St. Lucia, and St. Vincent and the Grenadines.

Disturbingly, there were no reliable figures for Haiti, leaving a void in understanding the full extent of the crisis which, in any event, is known to be completely unmanageable.

Statistics for the region reveal a grim reality;

eight out of ten countries with the highest homicide rates in the world are located in Latin America and the Caribbean.

The average homicide rates, according to 2021 data, stood at 9.3 per 100,000 for South America, 16.9 per 100,000 for Central America, and 12.7 per 100,000 for the Caribbean.

The Caribbean also grapples with a dual challenge: an influx of illicit firearms, primarily sourced from the United States, and a decrease in funding for crucial security initiatives.

The United States,

Ihe United States, despite being a major source of the region's illicit firearm woes, paradoxically reduced its budget for the Caribbean Basin Security Initiative by 11.8% in fiscal year 2022. This initiative provides vital aid for border

and port security, a lifeline desperately needed to combat the influx of weapons.

The alarming prevalence of Americanmade guns in the hands of Caribbean gangs has spurred heads of government to call for stronger U.S. efforts in curbing arms trafficking. In June 2023, Bahamas' Prime Minister, Philip Davis, emphasised to U.S. Vice-President Kamala Harris, the urgency of reducing the flow of illegal guns entering his nation from the United States.

However, the U.S. account of the meeting made no mention of this serious concern, not because the Biden government is not troubled by gun crimes, but because it is a domestic political issue in the U.S. Hence, not enough is being done to stop the flow of illegal weapons into the Caribbean.

Even as these nations grapple with the inflow of illegal firearms, their capacity to intercept and prevent such activities remains a signifi-

cant challenge.

Ports of entry often lack the necessary interdiction capacity, and limited enforcement resources hinder their ability to curb the tide of arms. The traffickers exploit the short distances between Caribbean islands, utilizing go-fast boats and yachts to move weapons seamlessly across the extensive coastlines.

Efforts to control and combat this phenomenon have been ongoing since the late 1990s. Despite these efforts, gangs continue to proliferate, fuelled by drug traffickers who arm their criminal enterprises.

Recognising the urgency and gravity of the situation, during my term as President of the Organization of American States (OAS), I placed the topic of "Guns, gangs, and violence" on the agenda of the Permanent Council.

An expert panel, convened to address the growing crisis, proposed approaches to tackle the root causes and consequences of criminal gang violence,

particularly gun-related violence. The resulting Resolution, adopted on December 12, emphasized the necessity for greater collaboration between governmental agencies.

It acknowledged that no single state possesses the capacity to match the formidable resources available to organized criminals operating across borders

The resolution underscored the links between transnational organized crime, criminal gangs, and the vital importance of a crossborder, collaborative approach.

We strongly proposed that the matter be addressed at the upcoming OAS general assembly in June, with the objective of establishing practical systems of collaboration between Latin American nations and Caribbean states.

The criminals are organized; if governments and their law enforcement agencies fail to follow suit, the consequences will be more disastrous than they already are. But this alone, while a start, is not enough. Much more needs to be done. At the regional level, collaboration is paramount, as no single state can confront the vast resources of transnational organized crime independently.

At the national level, robust legislation, effective implementation machinery to punish drug traffickers, and prison reforms to prevent them from becoming recruitment centres are imperative.

Equally important is raising awareness among communities about the dangers, consequences, and sanctions associated with membership in criminal gangs and the possession and illegal use of figurature.

As the Caribbean confronts this multifaceted crisis, the imperative is clear: collective, resolute action is not just an option but an absolute necessity. The path forward demands a commitment to national, regional and hemispheric action.

Gangs, guns and lawlessness now threaten every person – the examples are too many to ignore.

As the gavel came down on the latest round of climate talks in Dubai, there were declarations of "we united, we acted, we delivered" from the COP28 presidency. This was met by a sense of déjà vu among delegates of the Alliance of Small Island States (Aosis), an intergovernmental organisation representing the nations most vulnerable to climate change.

In her post-summit statement, Aosis lead negotiator Anne Rasmussen expressed confusion that the UAE Consensus, COP28's final agreement, was approved when representatives from smallisland developing states (or Sids were not in the room.

While some delegates hailed the consensus as "beginning of the end" of the fossil fuel era, Aosis countered that the document contained a "litany of loopholes" which did little to advance the key actions needed to stave off climate breakdown

of climate change. The group had fought over 30 years in climate negotiations for this fund.

Additionally, Aosis identified fundamental areas required to save Sids from impacts such as sea-level rise, desertification and climate migration. The principal – and most contentious – is "a phase-out" of fossil fuels, the main driver of the climate crisis.

Scientific evidence is clear: rapidly eliminating coal, oil and gas is necessary to limit global warming to 1.5°C, as enshrined in the Paris agreement. Even at this limit, many small islands will face a drastic increase in coastal flooding from sea-level rise, and other effects which could render these countries uninhabitable.

"We will not sign our death certificate. We cannot sign on to text that does not have strong commitments on phasing out fossil fuels," said Cedric Schuster of Samoa, the Aosis chair at the negotiations.

In addition to keeping the 1.5°C goal alive, Aosis members emphasised the need to double the financing which helps states to pursue measures to adapt to climate change (such as building seawalls to protect from stronger storm surges) and to mitigate their emissions. Sids, including the Caribbean Community (Caricom), a political and economic union to which Aosis' Caribbean Sids belong, had consistently raised these priorities ahead of COP28.

**Shared problems** 

This unified approach is remarkable considering the diverse nature of the group of 39 low-lying Sids, scattered across the Caribbean, the Pacific and Indian Ocean and South China Sea. This bond is also necessary, as Sids comprise a mere 1% of the world's population, and often, the influence of national

delegations is diminished by financial and logistical constraints, such as access to visas. Such shared impediments arise because of the common history of colonialism and resource extraction which has bequeathed unique challenges to smallisland states.

Despite this past, and their relative tininess, Sids remain among the most biodiverse places on Earth. The ocean under their control is, on average, 28 times each country's land mass, and much of the natural wealth for Sids lies in their ocean.

But the toll of climate change is mounting on these states. Pacific islands such as Vanuatu, Kiribati and Tuvalu have seen atolls sinking. Caribbean islands such as Antigua and Barbuda, of the Commonwealth Dominica and the Bahamas have experienced devastating hurricanes. In the case of Barbuda, the upheaval caused by more violent storms has precipitated an attempt to transfer land from the island community to the goverment and transnational companies, threatening to disrupt more than 400 years of farming and fishing traditions.

The costs of failure

The UAE Consensus text "calls on" countries to "transition away from fossil fuels" and towards renewable energy. Tellingly, this formulation met with the approval of fossil fuel producers.

Other agenda items important to Sids at COP28 were deferred another year, including how markets for trading carbon offset credits will be regulated. Even the hard-won victory of a loss and damage fund may prove hollow, as its lopsided set-up gives donor countries disproportionate influence through the World Bank's interim role as host, and stacks the odds against recipients. Estimates suggest that

the combined total of US\$700 million (£556 million) pledged so far by wealthy, high-emitting nations to compensate the poorest and least culpable countries for climate impacts amounts to 0.2% of the annual cost of climate destruction.

And, despite the vastness of ocean space under the control of Sids and the increasingly recognised role of the ocean in sequestering carbon, much of the funding for ecosystem solutions to climate change has been funnelled into forests.

What lies ahead?

While there were encouraging moments at COP28, the outcome failed to provide a scientifically grounded and equitable blueprint for keeping the Paris agreement's goal alive. For Sids, the delivery of this mandate was a red line for the 2023 climate negotiations. However, Sids have not put their eggs solely in the basket of the UN climate negotiations.

Pacific islands proposed a fossil fuel non-proliferation treaty in 2015, as an international mechanism for managing a phase-out between nations. This year, Colombia, a country dependent on coal, oil and gas for half its exports, endorsed the idea.

Elsewhere, Aosis members including Antigua & Barbuda and Vanuatu are seeking advice on the legal obligations of states to prevent and remedy harm as a result of the climate emergency under the International Tribunal for the Law of the Sea and the International Court of Justice. African Sids have published a draft report outlining similar questions.

in the run up to COP29 in Azerbaijan, Aosis members will need to continue to explore other routes to compel wealthy nations to recognise the needs and circumstances of the world's most vulnerable states.

## The World's Richest Men Leave Women Far Behind—Amid Rising Economic Inequalities

**UNITED NATIONS** - The world's rich are getting progressively richer while the world's poor continue to be increasingly poorer.

ĺń a new report released January 15, Oxfam says the wealth of the world's five richest men has doubled since 2020 -even as five billion people were made poorer in a "decade of division.'

The study, published to coincide with the World Economic Forum in Davos, an annual gathering of mostly the world's wealthiest and business elites, lists the top five billionaires: Elon Musk \$245.5 billion, Bernard Arnault and family \$191.3 billion, Jeff Bezos \$167.4 billion, Larry Ellison \$145.5 billion and Warren Buffett

\$119.2 billion- totaling about \$869 billion in assets

The fortunes of the five richest men have shot up by 114 percent since 2020 while the world's poorest will not be eradicated for another 229 years, said Oxfam, a global organization that fights inequality to end poverty and injustice.

Oxfam predicts the world could have its firstever trillionaire in just a decade while it would take more than two centuries to end poverty. Asked about the status of women in a world of rising economic inequalities, Rebecca Riddell, policy lead for economic and racial justice at Oxfam América, told IPS: "Women pay the highest price for a bro-

ken global economy". Globally, she pointed out, men own US\$105 trillion more wealth than women-equivalent to

size of the US economy-and women earn just 51 cents for every \$1 made by men.

"Women are also especially harmed by the policies that fuel our inequality crisis, like tax breaks for the rich and cuts to public services," said Riddell, one of the authors of the Oxfam report on inequality and

global corporate power. They carry out the vast majority of unpaid care work, which is vital to keeping our communi-ties and economies afloat, and their labor is constantly undervalued in the workplace, she noted.

"We found it would take 1,200 years for women working in the health and social sector to earn what the average CEO at the biggest Fortune 100 companies makes in just one year,' declared Riddell.

Oxfam urges a new era of public action, including public services, corporate regulation, breaking up monopolies and enacting permanent wealth and excess profit taxes.

The study reveals that seven out of ten of the world's biggest corporations have a billionaire as CEO or principal shareholder. These corporations are worth \$10.2 trillion, equivalent to more than the com-bined GDPs of all countries in Africa and Latin

America.
"We're witnessing the beginnings of a decade of division, with billions of people shouldering the economic shock-waves of pandemic, inflation and war, while billionaires' fortunes boom. This inequality is no accident; the billionaire class is ensuring corporations deliver more wealth to them at the expense of everyone else," said Oxfam International interim Executive Director Amitabh Behar.

"Runaway corporate and monopoly power is an inequality-generating machine: through squeezing workers, dodging tax, privatizing the state, and spurring climate breakdown, corporations are funneling endless wealth to their ultra-rich owners. But they're also funneling power, undermining our democracies and our rights. No corporation or individual should have this much power over our economies and our lives —to be clear, nobody should have a billion dollars," he noted.

The study also singles out the following:

Despite representing just 21 percent of the countries in the Global North own 69 percent of global wealth and are home to 74 percent of the world's billionaire wealth.

Share ownership overwhelmingly benefits the richest. The top 1 percent own 43 percent of all global financial assets. They hold 48 percent of financial wealth in the Middle East, 50 percent in Asia and 47 percent in Furone.

Mirroring the fortunes of the super-rich, large firms are set to smash their annual profit records in 2023. 148 of the world's biggest corporations together raked in \$1.8 trillion in total net profits in the year to June 2023, a 52 percent jump compared to average net profits in 2018-

Their windfall profits surged to nearly \$700 billion. The report finds that for every \$100 of profit made by 96 major corporations between July 2022 and June 2023, \$82 was paid out to rich shareholders.

Bernard Arnault, the world's second richest man who presides over luxury goods empire LVMH, has been fined by France's anti-trust body. He also owns France's biggest media outlet, Les Échos, as well as Le Parisien.

Aliko Dangote, Africa's richest person, holds a "near-monopoly" cement in Nigeria. His empire's expansion into oil has raised concerns about a new private monopoly.

Jeff Bezos's fortune of \$167.4 billion increased by \$32.7 billion since the beginning of the decade. beginning of the decade. The US government has sued Amazon, the source of Bezos' fortune, for wielding its "monopoly power" to hike prices, degrade service for shoppers and stiffe for shoppers and stifle competition.

"Monopolies harm innovation and crush workers and smaller businesses. The world hasn't forgotten how pharma monopolies deprived millions of people of COVID-19 vaccines, creating a racist vaccine apartheid, while minting a new club of billion-aires," said Behar.

People worldwide are working harder and longer hours, often for poverty wages in precarious ánd ŭnsafė jobs. The wages of nearly 800 million workers have failed to keep up with inflation and they have lost \$1.5 trillion over the last two years, equivalent to nearly a month (25 days) of lost wages The report also shows how a "war on taxation" by corporations has seen the effective corpo-

rate tax rate fall by roughly a third in recent decades, while corporations have relentlessly privatized the public sector and segregated services like education and water.

"We have the evidence. We know the history. Public power can rein in runaway corporate power and inequality shaping the market to be fairer and free from billionaire Governments intervene to break up monopolies, empower workers, tax these massive corporate profits and, crucially, invest in a new era of public goods and services," said Behar. "Every corporation has

but very few are. Governments must step up. There is action that lawmakers can learn from, from US antimonopoly government enforcers suing Amazon in a landmark case, to the European Commission wanting Google to break up its online advertising business, and Africa's historic fight to reshape international tax rules."

Oxfam is calling on governments to rapidly and radically reduce the gap between the super-rich and the rest of society

- Revitalizing the state. A dynamic and effective state is the best bulwark against extreme corporate power. Governments should ensure universal provision of healthcare and education, and explore publicly-delivered goods and public options in sectors from energy to transportation.

- Reining in corporate power, including by breaking up monopolies and democratizing patent rules. This also means legislating for liv-ing wages, capping CEO pay, and new taxes on the super-rich and corporations, including permanent wealth and excess profit taxes. Oxfam estimates that a wealth tax on the world's millionaires and billionaires could generate \$1.8 trillion a year.

Reinventing business. Competitive and profitable businesses don't have to be shackled by shareholder greed Democratically-owned businesses better equalize the proceeds of business. If just 10 percent of US búsinesses were employee-owned, this could double the wealth share of the poorest half of the US population, including doubling the average wealth of Black households.

Top Grenadian calypsonian, cultural figure Val Adams journeys on despite medical issues

Despite medical complications, one Grenada's top calypsonians and cultural fig-ures, Valentine "Val" Adams, is still hitting the

Adams was one of the main acts, primarily singing Christmas Carols, during the 40th Anniversary Gala celebration last Month of Brooklyn-based Vincentian-American Independent National Charities, Inc. (VINCI) at El Caribe Country Club on Strickland Avenue in

"Although, like every-thing else, there were minor obstacles along the way, including a stroke which I experi-enced in 2017, I have continued to provide our communities and countries alike with beautiful, tries alike with beautiful, enjoyable music," Adams, a three-time Grenada Independence and Calypso Monarch in New York, told Caribbean Life over the weekend.

"I'm still going through therapy and medical treatment, especially for constant pain on my left hip," added the four-time Calypso Monarch finalist oaypso wonact maist in Grenada, and twice second runner-up, with hits like "Take a Bow", "Rise Up" and "Bumsy". "I still perform as I see fit, by God's grace."

Adams, who was also twice Soca Monarch finalist in Grenada and founder of the House of Fire Calypso Tent in New York, said he introduced one of Grenada's traditional mases, "Shortknee", to the West Indian-American Labor Day (Brooklyn. Carnival

He said his mas band, "500 Strong", has been named Band of the Year, in the small band category, for three consecutive years, 2013-2015, in the West Indian-American Day Carnival Parade on Brooklyn's Eastern Parkway.

After Grenada's Independence and Calypso Competition in New York had paused, Adams said he "committed not to compete and instead spearheaded the restart of the event, which I continued for six

He said his musical journey continued with many recordings over the years, "with awe-some performances" in London, Toronto, Montreal, "and, of course, in New York and the Caribbean."

"I also enjoyed performing with the Mighty

Sparrow (the undisputed Calypso King of the World) many times in those cities, as well," said Adams, adding that his biggest accomplishment was when The City of New York hon-ored him with a proclamation for his contribution to the culture of the

city. He also won the Grenada Diaspora Cultural Award in New

"I have been given citain New York, again for my contributions to the city, and by the Government of Grenada during the annual independence celebrations," said Adams, the son of a church organist mother and school principal fathe, from the town of Sauteurs, in the parish of St. Patrick, Grenada.

Adams said he is the last of five sons, with the only sister, Pat, following him.

He attended both the St. Patrick Anglican and Catholic schools, and obtained a scholarship to attend McDonald's

College, where he was selected as a member of the Grenada Under 19 soccer team.

Adams said he was then transferred to the Grenada School Secondary School (GBSS), and was selected on the soccer team there as well, becoming captain of the team in 1969.

"As I always have a passion for sports and music, I took the opportunity to try athletics and won the junior champion athlete of the school and also senior champ thereafter," he said. "I have won Grenada's first CARIFTA Games medal in 1972, the silver medal, represented Grenada at Southern Games in Tripidad (and Games in Trinidad (and Tobago), and at the Windward Islands Games in St. Vincent (and the Grenadines), where I won one gold medal and one silver

Adams said he also obtained a certified soccer coaching license from the Southern New York State Coaching

Medgar Evers College after migrating to New

York.
"With great love for music, I seized the opportunity to listen and learn," he said, stating that his father played the violin, and his mother was an organist.

"There was a piano at home, and the radio was always on, of course," he added. "I was always on the piano, making some noise with two fingers. Occasionally, I was able to get some practice on a guitar, which my brother, Albert, would have borrowed.

"I was more fascinated by the guitar, gave it more attention, getting better daily, and even learnt to play bass on a

Surprisingly, one day, he said he was called to play bass guitar for a band, "which was about to be formed, Gary and the Rhythmeers, and got to sing my first song on amplified equipment, while playing bass gui-

Adams said the band was "very well accepted from its launch, and I continued as its bass player and lead vocal-

In 1974, the year of Grenada's independence, Adams said he was selected on the national soccer team to tour New York.

He said the first thought on his mind was "to try to apply for school, which I did and got

Adams said he attended Hunter College and Nassau Community College later, studying accounting and music.
"But most exciting of all

as a young man, with the advent of music, was when I was invited to a meeting by Terence Romney concerning the formation of a band," he

There, he said he met Eugene Grenada's Pursoo, former Ambassador to the United Nations, "who United Nations, "who immediately bought the equipment to start the group, Exodus.

Adams said he ended up being leader of the band, keyboard player and lead vocalist.

"The band had become very popular, and I

gained great recognition.," he said.

But after about 15 years, as members built their futures and moved to their separate ways. Adams said the group disbanded, and he went solo and started record-

ing.
"Val Adams Exodus was the best experience for me," he said. "I became a better singer, musician, enter-

singer, intertainer, arranger and songwriter.

"To my family, fans and friends, I want to thank you all for your continued support and appears." ued support and encouragement," Adams added. "Above all, I thank God for his mercy, and pray for His Blessings to everyone. I love you all.'

## JNRAVELING MYSTERY BEHIND FATAL 2020 CRASH



eceased Horndell Andall the official cause of death

The St. George's No.2 Magistrate's Court has initiated a Coroner's Inquest to probe into the tragic January 3, 2020, early morning crash that claimed the life of 32-year-old Businessman, Horndell Andall of Corinth, St. David.

Legal counsel for the family, Attorney Jerry Edwin on Wednesday confirmed that Magistrate Tahiera Gellineau is overseeing proceedings, scheduled to resume "during the second week of February," at the No. 2 Magistrate's Court within the

Southern District.

The primary objective of the inquest is to ascertain the official cause of Andall's death just over four (4) years ago.

The 32-year-old, who was affectionately known as 'Santana' was the driver of a blue Nice of Tale that collided with a load.

blue Nissan Tida that collided with a Jeep Wrangler around 7:00 a.m., on the tragic day, resulting in his death despite efforts to rush him to the St. George's General

Hospital.
A notable aspect of the inquiry is the

absence of eyewitnesses to the fatal acci-

Attorney Edwin has clarified that "there were only motorists passing by and persons who heard the crash, but in terms of persons actually seeing the point of impact with their own two (2) eyes that never occurred." occurred.

The circumstances surrounding the crash have sparked speculation, with indications that Andall's fondness for loud music and fast driving may have played a role.

Despite the challenges posed by the circumstantial nature of the inquest, Attorney Edwin remains hopeful about uncovering the truth.

Known colloquially as "a bad boy," Andall operated a popular bar on St. John's Street, and had legal matters pending before both the Magistrate's and High Courts in St. George up to the time of his untimely death, which was the first road fatality proorded in 2020. fatality recorded in 2020.
